JUDGING

All pieces of art must be brought to the Sackets Harbor Arts Center by 2:30PM Sunday, July 22, 2012. Judging will follow.

SILENT AUCTION

Anytime during the three day event, bidders may write a bid down at the artists' work station. All pieces submitted for judging will have no less than a \$50 minimum bid for sale.

FINAL AUCTION

Bidders may continue bidding after the entries are brought to the gallery on July 22nd. End of bidding will be announced 10 minutes after the judge announces the winners, at approx. 3PM. Phone in bids will be accepted.

SALE OF ARTWORK

All artwork sold is subject to 7.75% Sales Tax. Artists will receive 70% of sale price, mailed to the artist's home address upon clearance of funds by AANNY. AANNY will retain 30% of sale price. Artwork sold during the auction becomes the property of the Buyer who assumes responsibility to pay for and pick up the artwork in person or to pay for and make arrangements for its shipment.

CASH AWARDS

1st Place: 40% of all entry fees collected
2nd Place 25% of all entry fees collected
3rd Place 15% of all entry fees collected
AANNY will retain 20% of entry fees collected.

Artists are encouraged to bring their previously created work for display & sale at their site (they set price-keep money).

The Gallery will remain open Friday, July 20th until 8PM; and a reception will be held at the gallery on Saturday, July 21st from 5-6PM. Artists are encouraged to gather and socialize.

RULES

It is our goal that the 2012 Sackets Harbor Plein Air competition will closely follow currently accepted Plein Air guidelines for national level Plein Air competitions. The following guidelines have been incorporated for this year's judged event, which should make your experience of Plein Air painting in Sackets Harbor both enjoyable and fair to all.

1. All artists must register (sign-in if pre-registered) at the Sackets Harbor Arts Center, 119 West Main Street, between: 8AM-5PM on Friday, July 20th or Saturday, July 21st or Sunday, July 22nd from 8-10AM.
2. Each blank canvas, or painting surface intended to be used by entrants will be inspected for complete "blankness", and marked with AANNY certification marking at beginning of competition, or at time of entry. Each subsequent painting undertaken by the entrant must be so inspected and marked. Any works entered for final judging must bear the AANNY certification marking. There may be no pre-applied sketches, or paint applications on works entered for final judging.
3. Use of reference photos at work stations is not allowed.
4. Artworks may not be completed from reference photography, and must be direct paintings of the scene surrounding the artist.
5. Artworks are not to be framed or matted prior to judging. Artworks will be judged in original stand-alone painting supports/substrates only as they have been completed in the field.

6. The artist may supply additional framing, matting, or mounting for viewing or sale after judging is completed. It is the responsibility of the artist, in the event he/she intends to sell their artworks, to provide suitable support, mounting, and or framing devices that can be used after judging, so that artworks purchased can be transported to the satisfaction of the buyer.
7. Artists may create as many pieces as desired. See #2
8. A limit of 3 (three) pieces of artwork per artist may be entered for judging.
9. Only two-dimensional artwork accepted. No photography, or prints allowed.
10. All artwork must be completed in an outdoor setting, within the village of Sackets Harbor. In the event of inclement weather, organizers identify an indoor area where artists may work.
11. It is the responsibility of the artist to secure any permission needed to paint on private properties within the competition area.
12. Artwork for judging must be brought to the Sackets Harbor Arts Center by 2:30PM on Sunday, July 22nd.
13. All artwork will be considered for sale, unless stated NFS (Not For Sale) by the artist.
